
# St. Mary the Virgin, Bletchingley Giving for God's purposes



Do you love this beautiful ancient church at the heart of our village?

Then, this is how you can help preserve it!

## **Giving for God's Purposes**

We have been blessed as we engaged in mission in this parish and continue to look after our beautiful church each year. Missional growth is achieved when we offer our time, talent and finances to encourage the next generation of worshippers at St. Mary's. Since my arrival, we have utilised our volunteers' talents and encouraged growth in that area. It is a blessing of time and talents, for which we thank God.

It is very healthy for a church to speak about money and to share with clarity about our needs and how you can help. This leaflet outlines our figures and the challenge to meet our financial needs. As your priest, I am responsible for matching our financial needs with our spiritual growth and mission activity.


First, I want to set out the spiritual foundation of why we ask for generosity and how we continually give thanks for God's blessing. I believe there are seven components to our giving in our time and talents:

- 1. **To Give regularly:** The Bible tells us to give "on the first day of every week". While money may be tight during some periods of our lives, the failure to give is a spiritual problem for the most part. It is hard to imagine God accepting excuses for not honouring him with treasures (1 Cor 16:2 & 2 Cor. 9:8).
- 2. **Give cheerfully**: Receiving is lovely, but the joy is more remarkable when you can give to another person. The Holy Spirit uses your giving of time, talent and finances to deepen your faith in Christ (2 Cor. 9:7).
- 3. **Give proportionately** to your income, not a specific amount. Likewise, with your time, offer freely what you have available. Proportionate giving challenges people, irrespective of their financial or time situations.

- 4. **Give first fruits**: Give God the first portions of your income and your talents. By doing that, you constantly remember God's ownership (Proverbs 3:9). God has blessed our income, too.
- 5. **Give by faith**: Faith is an outward expression of your priorities and heart. If you put God first in your life, your talent, time, and finances will be open to him. The miracle of stewardship is that the more you give, the more you receive. You won't always receive in kind, but what you receive is more precious than what you offer because God's gift to you is greater than your gifts to him.
- 6. **Tithe**: Tithing is the practice of honouring God with one-tenth (10%) of your income. The size of your gift is not a concern by God but the motive for it (Gen.28:10-22). My only interpretation of tithing is giving God a portion of your best, not your leftovers. This is the only way I know how to give across all of my giving to Christian causes. I heard the call to come and serve among you; I feel blessed to give generously each month to both parishes of this benefice.
- 7. **Give sacrificially**: Sometimes, God asks you to give until you genuinely feel the giving. Giving sacrificially may include rearranging your priorities, changing your lifestyle, or forfeiting something of great value. When you give sacrificially, you give your best (2 Corinthians 8:2-3).

As you consider our needs below, I encourage you to reflect upon your generosity and how you directly contribute towards our mission here in Bletchingley.

## **COST OF A PRIEST**

The most significant cost for any Church of England church is usually the financial commitment of having a priest.

The indicative costs for a full-time priest for United Benefice are circa £86,300 in 2024. Each parish pledges to pay it through the diocesan scheme *Parish Support Fund*. These costs are explained in the summary below and in the booklet published by Southwark Diocese, which is available online:

In 2023, the indicative costs for the benefice were £83,500; St. Mary's element was £62,625 but was able to offer £67,400 towards these costs for things such as a Stipend for our priest, National Insurance, and also diocesan overheads such as training and safeguarding. Offering more than what was requested helps poorer parishes.

Those costs are split according to Father Paul's time: 75% for St. Mary's and 25% for St. Peter and St. Paul.


## **OUR EVERYDAY COSTS**

In addition, we face several very significant other costs, including our organist (£7,500), administrator (£6,800), Insurance (£5,565), utilities (£4,000) and our rental for Church House (£3,600).

We factor in a small amount for repairs and maintenance. However, significant repairs are usually made from a specific appeal or our reserves. These and all the other miscellaneous costs in the chart above bring the total to £104,680.

And how is all this paid for?

This chart shows the breakdown of our sources of income. As a worshipping community, each has responded generously to our needs according to their ability. Below is what our predicted income could be, considering what was received in 2023 and some increased giving.



## **GIVING THANKS FOR GIFTS RECEIVED**

Far and above, the most significant source is you; we thank you for your generosity, plus some well-wishers who do not attend church regularly; you contribute some £65,000 a year in regular giving, which is very impressive. Gift Aid significantly augments this at £17,000, where we can claim the tax back you originally paid before you made the donations. In 2023, our income was affected by regular giving ceasing because of death or personal circumstances changing. Other sources of cash are collections in church, fees for weddings and funerals and interest received, bringing the total to some £97,725.00.

But if we compare our costs with our income, we can see it is not sufficient to cover them, as shown by the hatched area at the top of the right-hand column below:



This amounts to an annual deficit of £8,235

So, what do we need?

Well, one-off gifts are much appreciated, but we need regular, committed giving. This could come from increases from those who already give regularly; quite a number of you responded to our last appeal in 2023, and our thanks to all those people.

Quite a few people come to church regularly, and I am sure they contribute to the collection taken in church but are not members of our Stewardship programme. Would you like to join? If so, have a chat with the Treasurer.

So, how can individuals help? I stress that there is no set sum, and you must decide what is right for you. For example, if ten new members joined up and contributed an average of £30 a month, that would be £3,600 per annum, which could increase to £4,500 with gift aid.

Also, if those who already contributed but could not increase their giving last year increased their giving by 10 per cent (inflation in the previous two years), we would raise £4,600, including gift aid.

The two together would then get us into positive territory where we were paying our way, but we realise this is a big ask and stress that there is no set sum, and it is entirely up to you as individuals.

# Parish Support Fund Cost of a priest: Indicative total ministry costs 2024 £86,300.00



The indicative cost for a full-time priest for the United Benefice of Bletchingley and Nutfield is £86,300 in 2024.

Each parish pledges to pay it via the diocesan scheme *Parish Support Fund.* 

These costs are explained in detail in the booklet published by Southwark Diocese, which is available electronically.

Set out opposite is a summary of those costs.

Those costs are split according to Fr. Paul's time:

St. Mary's uses 75% of his time, equating to £64,725.

St. Peter and St. Paul uses 25% of his time, equating to £20,900.
